Dear Mr. Korkut:

Thank you for your May 11, 2018 letter addressed to ICBC interim President and CEO Mr. Nicolas Jimenez regarding ICBC operations. It has been referred to me in the ICBC Customer Relations department for review and response.

As you state, ICBC's role is to provide Basic motor vehicle insurance in the province of British Columbia. If a driver is found to have committed a hit and run or a criminally negligent act, it would be up to law enforcement to charge and fine them accordingly. ICBC would then breach their insurance policy and they would be responsible for paying all vehicle damage and any injury claims made against their policy. Section 77(2) of the Insurance (Vehicle) Act gives ICBC the right to recover cost of a claim when an insured is in breach.

Any motor vehicle related Criminal Code (Canada) offences carry ten Driver Penalty Points which must be paid before ICBC will issue further insurance or renew a B.C. driver's licence.

Further, drivers who cause accidents pay more for their insurance, while drivers who do not, receive a safe driving discount.
